









Minutes of the Meeting

2. If a candidate has not selected Delhi University as a preference while registering for CUET-UG can still apply for admission to the university through the varsity's CSAS portal.
3. If a student has not selected desired programmes in CUET, he/she can also apply for the programmes during phase II of the CSAS.
4. The second phase of the CSAS (UG) process will commence with the declaration of the CUET (UG) results in the second week of July.
5. For admissions under OBC and EWS categories certificates issued after 31.3. 2023 will valid.









Minutes of the Meeting






Minutes of the Meeting

1. Initially there was problem in getting access to CBSE Marksheets at the college level due to some technical glitch, the delayed response due to this brought about the grievance calls from candidates. This was properly addressed.
